

FREQUENCY COMPARISON (H–MASER 40 3845) – (SU–CsFO2) For the period MJD 59879 to MJD 59909.

The primary frequency standard SU–CsFO2 has been compared to the hydrogen Maser 40 3845 of the laboratory, during a measurement campaign between MJD 59879 and 59909 (27^{th} October 2022 – 26^{th} November 2022). The fountain operation covers ~ 82.7 % of the total measurement duration for the period MJD 59879 – 59909. The mean frequency difference at the middle date of the period is given in the following table:

For the uncertainty due to the clock link $u_{Link_Lab} = 0.1 * 10^{-15}$ is obtained by taking into account the actual measurement time.

The CsFO2 standard uncertainty u_A is estimated as 0.24 * 10⁻¹⁵ (1 σ) for the relevant periods.

Accuracy

The following table summarizes the budget of systematic effects and their associated uncertainties. The accuracy is the quadratic sum of all the systematic uncertainties.

$$u_{\rm B} = 2.2 * 10^{-16}$$

Uncertainty due to the dead times

During the evaluation period there were gaps in the data collection (dead time) due to both intentional and unintentional breaks. Most of the unintentional breaks were caused by failures of the laser locking systems (due to rapid change barometric pressure).

The standard deviation of the fluctuations of frequency due to the dead times in

measurements is estimated by the ratio $\frac{\sqrt{\sum_{i} \sigma_{x_i}^2}}{T} = \sigma_{Dead_Time}$

Period (MJD)	$\sigma_{\text{Dead}_{\text{Time}}}$

The uncertainty on the link Maser is obtained by the quadratic sum of the link lab uncertainty and the uncertainty due to the dead times calculated above:

$$u_{\text{Link}_\text{Lab}} = 1 * 10^{-16}$$

$$u_{\text{Link}_{\text{Maser}}} = \sqrt{(\sigma_{\text{Dead}_{\text{Time}}})^2 + (\sigma_{\text{Link}_{\text{Lab}}})^2}$$
